# 3 WORKING SESSION OF THE BOARD - STRATEGIC PLANNING

3.1 Data presentation; who do we serve? – Systems and Accountability Coordinator

Board members Halvorsen and Harrigan requested additional data regarding student demographics and withdrawal rates to be presented at the March Board meeting.

# 3.2 Strategic discussion—Executive Director

The Board discussed Strengths, Weaknesses, Opportunities, and Threats. These included MOU conditions, the impact of potential turnover among authorizing district staff and Board members, the impact of potential future legislation and court decisions, and the advantages of a charter in Riverside county.

The Board provided guidance to the Executive Director to pursue a "dual track" for establishment of a new Pivot North Bay charter: continue with the charter petition that was submitted to Santa Rosa City Schools, and appeal to Sonoma County Office of Education if the district denies the petition; and also submit a new charter petition to Oak Grove Union School District.

3.3 Update on planning to meet Chico Unified School District criteria – Program Director and Systems and Accountability Coordinator

Board members expressed praise and support for the program changes being implemented by school staff in response to CUSD MOU conditions, and offered guidance to school administrators on managing the transition from Golden Feather USD to Chico USD as the authorizing district of Pivot North Valley.
